SESSIONS

TIME: All players are responsible for scheduling their own match times
(a minimum of 5 matches is required to be eligible for the ladder)
COST: Registration only- \$15 / person Normal court fees apply
LEAGUES: Men’s 8.0/8.5 , Men’s 7.0/7.5 , Women’s 8.0/8.5, Women’s 7.0/7.5

Ladder League Guidelines and Format

Setting up Matches

1. Teams may issue challenges to any other members in their league. Contact information can be found at the front desk or by your league administrator.
2. Players must make every effort to make and accept proper challenges both upward and downward.
3. If a challenge cannot be agreed upon with a particular team, try another.

League Play

1. The time and day for the match must be mutually agreed upon.
2. **Players can only book a court 48 hours in advance. Normal Court rate fees apply. Members can use court packages and unlimited monthly court time passes.**
3. **Balls - Each team is responsible for bringing a can of balls. Winners take home the unused can.**
4. If a match is interrupted for any reason, it may be continued to completion at another time by agreement of both teams. Or the team leading the match at the point of interruption can be considered the winner. A match is only valid if at least one set has been completed. Both players must agree to the settlement. If no settlement can be made, the match must be completed or replayed at a later date -otherwise do not enter a score. Games must be added to the score to make a complete match - Do not enter incomplete match scores.
5. All matches will use a 2 out of 3 set format with a 10-point tie breaker in lieu of the third set.
6. Unless otherwise stated, all competition will comply with USTA playing rules.

After the Match

1. The winner should enter the match results into the league binder which will be available at the front desk.
2. The league administrator will make every effort to update the Ladder on a timely basis.

Ladder Rankings

1. Every team must play a minimum of 5 matches to be eligible for a spot on the ladder.
2. We will be using a "15 point system"
 - a. Winner of the match receives 15 points regardless of previous ranking.
 - b. The loser receives 1 point for each game they win.
